LICENSE TO PUBLISH

A. This License to Publish (the "License") must be signed by all authors of any manuscript submitted for publication in *Oceanography* (hereinafter, the "Article"), including the lead author and all contributing authors (all authors, collectively, the "Contributing Authors"). If possible, the lead author should sign this License, route the original to all other authors, and return the fully executed License to the Assistant Editor when all signatures are obtained. If it is not possible to accomplish this within a reasonable time, copies of this License may be emailed or faxed to each Contributing Author, each of whom must sign and email or mail the signed License to the *Oceanography* Assistant Editor at the address(es) stated below.

C. In consideration of the publication of the Article in *Oceanography* magazine, the Contributing Author(s) hereby grant to The Oceanography Society (the "Society") the following rights:

1. A non-exclusive worldwide right in perpetuity to publish the Article in any format, including without limitation physical printing in a collection or magazine or as a reprint; as a page or pages on one or more websites, or by means of any similar or successor mode of presentation; and/or as a file available through, and downloadable at, the Society's websites, in any format.
2. A non-exclusive worldwide right in perpetuity to exercise, with respect to the Article, all rights provided by the Creative Commons Attribution 4.0 International License ("CC BY"), including without limitation the rights to copy the Article, distribute the Article, to make derivative works based on the article, subject to the conditions contained in the CC BY license. For reference, the terms of the CC BY license are available at: <https://creativecommons.org/licenses/by/4.0/legalcode>. The terms and conditions of the CC BY license are incorporated herein by reference.
3. To the extent not already granted by items (1) and (2) above, all rights necessary to permit the Society to publish the Article under the terms of the CC BY license.
4. The right to use the names, likenesses, and biographical information of the Contributing Author(s) in connection with the Article and in any promotion or advertising therefor; provided that if the Article is published, the Society shall credit the authorship of the Contributing Author(s) of the Article in each published version thereof, consistent with and as required by the CC:BY license.

The Contributing Author(s) retain the all rights in the Article, including all copyright rights in the Article, subject to the grant of rights to the Society provided above.

D. In addition to the foregoing grant of rights, the Contributing Author(s) each represent and warrant to the Society as follows:

1. That they are the sole author(s) of the Article;
2. That the Article is original and does not infringe upon any copyright, or any other right whatsoever of any person or entity;
3. That the Contributing Author(s) have the full power to grant the rights conveyed to the Society under this License;
4. That they have obtained or will obtain all the necessary rights, licenses, and clearances and have paid or will pay all of the required fees (if any), and will advise the Society of any credits required to be given, for the incorporation of any illustrations, photographs, text, or any other materials owned by any third party in the Article provided to the Society by the Contributing Author(s) for publication (the "Third Party Materials"). If any Third Party Materials are utilized in the Article, the Contributing Author(s) shall identify such materials and provide to the Society copies of any applicable licenses, releases, or permissions.
5. That the Article has not been published previously and is not under consideration by any other publisher.
6. That if the Article was submitted for publication to another scientific or academic journal and rejected for publication for any reason by such journal, the Contributing Author(s) have fully disclosed such prior submission and rejection to the Society.

- E. The Contributing Author(s) agree that during the period beginning with the first delivery of the Article to the Society and ending on the earlier of (a) the date of publication of the Article in *Oceanography* or (b) twelve (12) months from the date of the signature of the last Contributing Author to sign below, the Contributing Author(s) shall not submit the Article elsewhere for publication.
- F. The Contributing Author(s) shall pay the Society any Publication Charges applicable to the publication of the Article. The required Publication Charges (if any) shall be as set out in the Society's Author Guidelines, available at: <https://tos.org/oceanography/guidelines>.
- G. The Contributing Author(s) will indemnify and hold the Society harmless from and against any claim, demand, damage, liability, cost, or expense (including reasonable attorney's fees), that may result from any claims, damages, losses, or costs arising out of the Contributing Author's breach of any of the representations or warranties made in this License.
- H. In consideration of the grant of rights to the Society and other agreements by the Contributing Author(s) provided herein, the Society agrees as follows:
1. The Society will conduct all editorial, peer review, and administrative activities associated with the Article reasonably and in good faith and without unreasonable delay.
 2. The Society will promptly advise the Contributing Author(s) if for any reason the Society concludes that it will not publish the article. If the Society chooses not to publish the Article, then any and all rights in or to the Article provided to the Society under this License shall immediately terminate.
 3. Any publication of the Article by the Society shall be under the terms of the CC BY license.
- I. This License expresses the entire agreement between the Contributing Author(s) and the Society, and may not be changed except by a writing signed by the Society and each of the Contributing Author(s). This Agreement shall be construed in accordance with the laws of the State of Maryland and, to the extent that it applies, federal law.
